Terms of Use

I- Acceptance of Terms

Welcome to the nomadinside.com website (the "Site" or "Website"). This Site is operated by Nomad Inside Limited ("we" or "us"). We provide this Site, any associated websites and related services to you according to the legal notice and other rules posted on the Site. Hereinafter, the notice and rules will be referred to collectively as the "Terms". "You", "Your" and "user" refer to anyone who accesses or is a visitor to the Site and the webpages located at the Site. Please read these Terms carefully and, in particular, these Terms of Use, the Privacy Policy, and the Shipping & Return Policies. Please note that your use of this Site, or any purchases you make on this Site, constitute your agreement to follow and be bound by our Terms (the "Agreement"). Please be aware that we reserve the right to modify and update the Terms and this Agreement from time to time, without notice, and such changes will become effective and binding upon you upon posting herein and your use of this Site. The General Terms and Conditions of Sale apply to all orders placed with the Nomad Inside Limited company for all items and services offered on the site nomadinside.com. They can be accessed at all times on the Website. Consequently, the action of placing an order implies complete adherence, without reservation, to these terms and conditions. Therefore, we encourage you to visit this page from time to time to review the current terms and conditions. If for some reason you cannot agree to the Terms or this Agreement, or are dissatisfied with the Site or any content therein, then you are not authorized to use this Site and your sole and exclusive remedy is to stop using the Site. Your continued use of this Site following any changes, modifications or amendments to the Terms constitutes your acceptance thereof and your agreement thereto. We reserve the right, at any time, to discontinue or change this Site or its availability to you, and we can reject, refuse, restrict, suspend or terminate your access to all or any part of this Site.

II - Customers

At the time the customer registers their personal information, the customer must ensure the accuracy and completeness of the data they provide. If an error occurs in the wording of the recipient's details, Nomad Inside cannot be held liable for any inability to deliver the product.

III - Products

The products offered for sale are those described on the Website on the day the internet-user consults the Website, within the limit of available product stock of components (stones, gold, chains etc..). Nomad Inside takes the greatest care in the presentation and description of these products in order to provide the customer with the best possible information. However, it is possible that non-substantial errors may appear on the Website, which the customer acknowledges and agrees to.

In any case, in the event of nonconformity of the product delivered compared to its description on the Website, the customer may either exercise his right of withdrawal, or implement the Nomad Inside guarantee of conformity which will, where appropriate, result in an exchange or refund of the price (in whole or part) that has been invoiced.

IV - Orders

Acceptance of an order placed on the Website is subject to compliance with the procedure put in place by Nomad Inside, expressed by a succession of different stages that the customer must follow in order to validate their order. Any order validated by the customer is in accordance with the contract of sale and acceptance of all of the clauses of these terms and conditions. An email confirmation summarizing the order (products, prices, product availability, quantity, estimated delivery date etc.) will be sent to the customer by Nomad Inside. For this purpose the customer formally accepts the use of email for receiving confirmation of the contents of their order from the company Nomad Inside. In any event, the invoices are available in the 'my account' section. The customer has 15 (fifteen) calendar days to exercise their withdrawal period from receipt of the package.

V - Prices & Terms Of Payments

The prices of products are indicated in euros, inclusive of all taxes, but excluding shipping costs.

The total price of the order (including all taxes and shipping) is indicated in the basket. All prices are calculated inclusive of value added tax (VAT), which may be different depending on the country of billing.

For sales outside the European Union, prices are understood to be FOB, sent from Hong Kong. Customs clearance, and the payment of various duties or taxes are your responsibility.

Nomad Inside reserves the right to modify its prices at any time but the products will be invoiced on the basis of the rates in force at the time of placing the order, subject to availability.

The products are payable on the day of the order.

The purchases shall be settled either via PayPal which accepts PayPal payment, Visa and Master card. The customer expressly acknowledges that disclosure of their bank-card number to Paypal gives PayPal the authorization to debit their account to the amount of the products ordered.

The data recorded and kept by Noamd Inside constitutes proof of the order and all previous transactions. The data recorded by PayPal constitutes proof of the financial transactions.

VI - Delivery

Deliveries are carried out by Fedex or DHL, Monday to Saturday, depending on the best option at the time of the shipment to better serve the customer. The delivery is made to the delivery address indicated by the customer, being specified that it must be the address of the customer's residence, an individual of their choice or a legal entity (delivery to their company). Deliveries cannot be made either to hotels or P.O. boxes.

Most of our products are handmade items, and therefore made to order items. The making takes 2 to 4 weeks. Please allow for order processing, making and shipping time

and you will have the total estimated turnaround time. Orders are shipped on average every 2 (two) days, but the period may be extended up to 10 (ten) working days. For a better customer experience, the customer must make sure that they have provided accurate and complete information concerning the delivery address (including in particular: house number number/name, building number/name, staircase, access codes, names and/or numbers for the intercom, etc.).

In case of any delay, we will contact you promptly by email. Should you need to receive your order by a specific date and time please kindly contact us at contact@nomadinside.com. We will be able to advise you more specifically.

NOMAD INSIDE will deliver orders within a maximum delay of 4 to 6 (four to six) weeks from the day after the validation of the order & payment reviewed. If the delivery time is exceeded and is not justified by a case of force majeure, the customer may request the cancellation of the sale and within a maximum period of 15 (fifteen) days can receive a refund of sums paid on the occasion of the sale.

The timescales indicated are indicative deadlines, corresponding to the average time for processing and delivery. NOMAD INSIDE cannot be held responsible for any consequences due to a delivery delay not of their own making.

VII - Refunds & Returns

We want you to be completely in love with your NOMAD INSIDE jewelry. If you were not satisfied with your purchase just return it **unworn**, in its original packaging, and accompanied by its certificate of authenticity and the original sale receipt **within 7 calendar days of receiving your order**. Please follow the simple steps below in order to return your NOMAD INSIDE purchase:

Within a period of 7 days following the receipt of their order, the customer may request reimbursement of the order. Return of the product(s) is the responsibility of the customer if the order was placed from abroad and is at their own risk. Product(s) must be returned in their original packaging, in their original state, brand new, not worn. To make a return, the customer must follow the procedure indicated on the return voucher received with the order.

1. Contact our retail assistant at contact@nomadinside.com to initiate the return process
2. Fill out the form with all of the details, making sure to report the initial invoice/order number on refund or exchange. Check that you agree with the refund policy
3. Once the request has been accepted by nomadinside.com, you will receive a confirmation email to proceed with your return/ exchange.
4. Pack your item carefully and include your original receipt and return document
5. Ship the package to:

For your security please return your item with an insured courier (i.e. FedEx, UPS).

NOMAD INSIDE is not responsible for the cost of returning items nor is it responsible for items damaged or lost in transit. Should you elect to get a refund, please note that all refunds minus the shipping are issued to the original form of payment. Please note that refunds can take up to 10 working days to show on your account due to varying processing time between payment providers. Sale items are final sale and non returnable.

The repayment term for NOMAD INSIDE to the customer in the event of withdrawal is 15 (fifteen) days, once the product, which the customer is returning, has been recovered.

In all cases, the expenses of returning the product are borne by NOMAD INSIDE if the product delivered is damaged or different from the product ordered. If the customer does not adhere to these terms and conditions, including conditions of return or exchange, Nomad Inside cannot proceed to refund the products in question.

VIII - Guarantees & Responsibility

Nomad Inside only has a best-efforts obligation for all stages of access to the Website, from the processing of the order to shipment of the package or subsequent services.

Nomad Inside cannot be held liable for any inconveniences or damages inherent to the use of the internet, including service breakdown, an external intrusion or the presence of computer viruses, or any event or occurrence qualified by force majeure in accordance with the law and jurisprudence. Upon the occurrence of an event of force majeure, the concerned party shall inform the other within a period of fifteen (15) days of the occurrence of this event, by registered letter with acknowledgement of receipt.

Specifically considered as cases of force majeure or fortuitous event, in addition to those regularly cited by the jurisprudence of the Hong Kong courts and tribunals, are total or partial strikes, lockouts, riots, boycotts or other actions such as war, bad weather, epidemics, blocking of the means of transport or supply for any reason whatsoever, earthquake, fire, storm, flood, water damage, governmental or statutory restrictions, legal or regulatory modifications of marketing changes, computer failure, blocking of telecommunications, including wired or wireless telecommunications networks, and any other instance independent of the will of the parties preventing the normal execution of the contractual relationship. All the obligations of the parties will be suspended for the duration of the event of force majeure, without compensation. If the event of force majeure continues for more than three (3) months, the contract may be terminated without compensation for one or other of the parties.

The seller is obliged to deliver a product conformant to the contract and to respond to defects of conformity, which exist at the time of issuance.
